# ANNUAL REPORT

#### OF THE

#### BELLEVUE TRAINING SCHOOL FOR WOMEN NURSES.

THE Annual Business Meeting was held at the Nurses' Home, 426 East 26th Street on Friday, January 3rd, 1908.

The Board of Managers of the Bellevue Training School for Women feel that they can report this year a satisfactory working out in their new relations with the City.

On the completion of the two new allied hospitals, Fordham and Harlem, the nursing force of these hospitals was placed under the jurisdiction of the Bellevue Training School.

On April 29th Fordham, and on April 30th Harlem, were opened for the reception of patients. Such was the organization that the difficult work of moving all the patients from the old hospitals was accomplished in each case in one day, and on the following day all was running sufficiently smoothly to permit of several operations being performed. It was impossible to obtain sufficient pupil nurses to properly undertake the nursing service of two additional hospitals, and for the first few months the entire force was composed of graduate nurses at a salary of \$50 a month each.

We have now, however, through the initiative and power of organization of our Superintendent, Miss Goodrich, formed affiliations with certain hospitals who desire to give a supplementary training to their pupils in courses in which their own hospital service is deficient.

These are: the Long Island State and the Kings Park Hospitals, both institutions for the insane. The pupils from these hospitals obtain from us a general course, namely: surgical, medical, and obstetric. The Jackson Sanitarium and the Yonkers Hospital, who enter their pupils for medical and surgical work only. The Samaritan, Troy, N. Y., for a course in the care of infants and children. From the Washington Asylum, where the course is only two years, the pupils are sent to us for a third year general course which will include all the services. These are:

> Surgical Medical Operating Room Dispensary Infants and Children Obstetrics

This arrangement while meeting the needs of the Allied Hospitals enables these schools to qualify for State registration. The nurses receive the \$8.00 monthly allowance of the pupil nurse.

Aside from these affiliations we have been able to offer elective post graduate courses of not less than three months to nurses who hold diplomas from schools of good standing, and whose preliminary education has included at least one year in the High School. So many applications have been received from graduates of Training Schools for the care of the insane that we have arranged a nine-months' general course for them.

Examinations are held at the completion of the course, and if successfully passed, and the general work and conduct have been satisfactory, a certificate covering the courses will be awarded. Board, lodging, and laundry are furnished and an allowance of \$25.00 a month. All these nurses are subject to the regulations governing the Bellevue Training Schools and Allied Hospitals.

It is our purpose to further develop this post graduate work, providing more advanced courses for those showing special executive ability, thereby fitting them for institutional positions. These courses would include a certain time in the housekeeping departments, such as the kitchen, laundry, and the Nurses' Home, and in the office work of the Training School and Hospital. Fordham being exceptionally complete will afford special advantages in this line and the varied and heavy emergency service at Harlem offers a surgical and medical experience which it would be hard to duplicate. That the opening of these post graduate courses has supplied a need long felt by the profession is evidenced by the number of applications received, which have averaged between forty and fifty a month. We have accepted since the first of May some eighty post graduate nurses for courses varying from three to nine months.

The total force in Harlem and Fordham respectively now consists of about forty-two nurses, of whom, in each hospital, three are supervising nurses, eleven graduate nurses in charge of wards and different departments, and the remaining force affiliated and post-graduate pupil nurses.

On the 15th of February Miss Goodrich assumed her duties as General Superintendent of Training Schools. Miss Brink continues Superintendent of the Bellevue School for Women.

On the opening of the new Fordham Hospital Miss Marie Ferrier, matron of the King's Park State Hospital and a graduate of the Montreal General Hospital, was appointed Superintendent of Nurses and Acting Supervising Nurse, and served until November when she resigned. She was succeeded by Miss Frances Stone. Miss Stone was Assistant Superintendent of the Training School at the Presbyterian Hospital for some years and left there to organize the work and take charge of the Corey Hill Hospital in Boston.

On the opening of the new Harlem Miss Edith McCoy was appointed Superintendent of Nurses. She is a graduate of the Children's Hospital of Boston, and has held various positions in the Presbyterian and Sloane Maternity Hospitals of this city.

A very attractive Nurses' Home was built in connection with Fordham Hospital. At Harlem the majority of the nurses have quarters in the hospital but as there is not room enough for all, the Trustees have rented a pleasant house in 136th Street which provides lodging for thirteen nurses. A Nurses' Home is urgently needed.

Auxiliary Committees for supplying visitors to the wards have been formed at both Harlem and Fordham, the Chairman of each being a member of the Board of the Bellevue Training School and reporting monthly to that Board. The Chairman form their own committees from ladies not members of the Bellevue Board. The committees with Mrs. Herbert D. Robbins as Chairman at Fordam and Mrs. Francis K. Pendleton at Harlem have performed invaluable work, both in ward visiting and in assisting the Superintendents in providing many comforts for the nurses. These committees have not been organized for a sufficient length of time to give a complete report of their work.

Various changes have occurred in the administrative staff of the Bellevue Training School during the year. Miss Underhill, who was formerly assistant to Miss Wadley for the convalescent relief work was appointed as Superintendent of the Mills' School, but resigned on account of her health. She has been able, however, to take charge of the Admitting Office, a department which had not before been satisfactorily covered.

Miss Amy E. Holmes is now Superintendent of the Mills' School. Miss Holmes has had a wide experience in Cuba and in the Philippines during the Spanish War, and had charge of the wards in an Army hospital in South Africa during the Boer War. Miss Lulu Jones, who has held various executive positions in Bellevue since she graduated in 1902, resigned as Assistant Superintendent of Nurses in November to become Superintendent of the New Rochelle Hospital.

Miss Marie Louis, a graduate of the Class of 1907, was appointed Instructor of Probationers on March 2nd, Miss Gerrity the former Instructor having resigned.

Miss Jennie Nash, who held the position of Housekeeper of the Hospital resigned, and has been appointed Superintendent of the Latter Day Saints Hospital at Salt Lake City.

Miss Hattie Frost of the Class of 1906 received the appointment of Housekeeper to the Hospital.

Miss Frances Detwiler of the Class of 1902 was appointed First Assistant Superintendent of the Training School. In October Miss Edna Cutler was formally appointed Dietitian of the Hospital, and as such is giving a course in dietetics to both the Mills' and Women's Schools.

The increase in the number of probationers necessitated our arranging for further accommodations, and a very attractive dormitory with an adjoining bathroom has been fitted up over the dining-room and kitchen of the Probationers' House, No. 212 E. 26th street which will allow us seven more pupils.

Miss Van Sickle has carried on the work of this house with great interest and untiring zeal since it was opened, never having been absent for a day.

It would be hard to estimate the value of the instruction which is given in housekeeping to these pupils. As Miss Van Sickle now shows the effect of this arduous duty, we feel that she has well earned the two-month's vacation which she is about to take.

The graduating class this year numbers thirty-three, all having passed their examinations satisfactorily. The Managers have agreed this year to inaugurate the custom of holding the graduation exercises in April instead of in January as formerly. It is believed that this will conform better with the school year and will be more convenient to all.

The annual meeting will be held as before in January.

Nine hundred and sixty-three inquiries for application to the School have been received during the year. Seventy-two probationers have entered and thirty-five have been accepted.

One of the most difficult problems which confronts us each year is the relieving of the nurses for their vacations during the summer months, with a service which remains as heavy or frequently is even heavier than in the winter. Last summer an appropriation made by the Board of Trustees to cover the cost of graduate nurses for vacation reliefs, much lessened this strain, enabling us to give over fifty vacations of periods from four to six weeks, without seriously interfering with the hospital service.

While there has been some serious illness, the health of the School on the whole has been good. Five nurses have been taken care of at the Minturn Hospital suffering from diphtheria and one from scarlet fever. They have received there every care and courtesy. We have also had two cases of typhoid and one of pneumonia; all of these cases having made good recoveries.

Four of the graduate nurses have been cared for in the Lazarus Pavilion.

The Edith Home has been open during the summer, and many of the nurses have enjoyed their vacations there. We are deeply indebted both to Dr. Carlisle and to Dr. Coakley for their constant and untiring care of the nurses.

Dr. Rimer, of the Quarantine Station gave some most interesting lectures on the care of contagion, and on July 30th, through Dr. Doty, arranged a very instructive trip to the Quarantine Station for some thirty nurses.

The Bellevue School Census now is:

Some five Nurses taking post graduate courses and three

pupils from Schools with whom we are affiliating.

The work at the New Home is progressing and we look forward to seeing the new wing of the Hospital opened in the spring.

We believe that it will be demonstrated, from the point of view of the Training School, that a greater number of patients can be cared for economically in one large hospital than in many small ones, from the fact that while housing many more patients with every comfort and convenience, no proportionate increase in the supervision will be required.

The After Care of Convalescent Relief Work started in July, coo6, with Miss Wadley in charge, has achieved such results that it has become permanently established in the Hospital, necessitating the formation of a Convalescent Relief Committee.

This Committee is appointed by the President of the Board of Managers of the Training School, but not from among the members of the Board. Its duties are to collect and receive money for the Emergency Fund of the work, to oversee its disbursal and to co-operate in every possible manner with the Department of Charities, the various organized Charitable Societies and Institutions, and the Department of Bellevue and Allied Hospitals. It is hardly possible to exaggerate the amount of good which may be done by help given through this Committee. Waifs and strays from almost every class of society find their way to Bellevue, and numberless are the cases, not possible to refer to organized agencies, where a little emergency aid may prevent families from being broken up through the illness of one member, and in many cases becoming dependent upon the community.

The various Charitable and Relief Societies of the city are cooperating most kindly with this Committee.

We wish to thank Dr. Armstrong this year as before for his unfailing support of our school and for his valuable advice and co-operation in its administration.

To Dr. Brannan and the Trustees we can only repeat our thanks and appreciation for all they have done for us.

We enter the new year hopefully, and believing that the School with the Hospital will be enabled to progress and continue in its earnest purpose of giving the utmost that skill and devotion can provide to the sick poor of New York, and in training a corps of women who may go forth into the world thoroughly equipped to take an honourable position in the noble profession which they have adopted.

#### REGULATIONS FOR TRAINING SCHOOL FOR NURSES.

THE Committee of the Training School for Nurses has made arrangements with the authorities of Bellevue Hospital for giving two years and six months' training to women desirous of becoming professional nurses.

Those wishing to obtain this course of instruction must themselves apply to the Superintendent of the Training School, 426 East 26th Street, New York, either in person or by letter, upon whose approval they will be received into the School for two months on probation. The preferable age for candidates is from twenty-one to thirty-two years. The applicant should send, with answers to the paper of questions, a letter from a clergyman testifying to her good moral character, and from a physician statting that she is in sound health. Applicants are received at any time during the year when there is a vacancy. A good education is *indispensable* for a member of the School, but applicants are reminded that women of superior education and cultivation, when equally qualified as nurses, will be preferred to those who do not possess these advantages.

The Superintendent has full power to decide as to the fitness of applicants for the work, and the propriety of retaining or dismissing them. She can also, with the approval of the Committee, discharge them at any time in case of misconduct or inefficiency. During the months of probation, the pupils are boarded and lodged at the expense of the School, but receive no other compensation. After the trial months, those who prove satisfactory will be accepted as pupil nurses, after signing the following "Agreement":

"I, the undersigned, hereby agree to remain at the Training School for Nurses two years and six months as a pupil of the School, and to conform to the rules of the School and the Hospital.

"I understand that the authorities of the Training School

have the right to dismiss me at any time and for any cause which they may deem sufficient, and if I leave the School before graduation, whether of my own free will or by dismissal. I hereby agree to give to the authorities of the Training School every portion of the uniform worn by me as a nurse."

The pupils will reside in the Home, and serve as Assistants in the wards of Bellevue Hospital; afterwards they will be expected to take charge of the wards, or to perform any duty assigned them by the Superintendent.

Pupil nurses will be allowed \$8.00 per month during the entire course. This sum is intended for uniforms, text-books, and other expenses of the nurse in connection with her work, and is in no wise intended as wages, it being considered that the education given is a full equivalent for her services. They are required, after the months of probation, when on duty, to wear the dress prescribed by the Institution, which is of blue and white seersucker, simply made, white apron and cap, linen collar and cuffs.

The day nurses are on duty from 7 A.M. to 7 P.M., with an hour for meals and additional time for exercise and rest. They are also given an afternoon during the week, and half of Sunday. A vacation is allowed.

As the Institution is unsectarian, there are no religious services connected with it, but all nurses are expected to attend the place of worship they prefer once on Sunday.

The instruction will be given by visiting and resident physicians and surgeons, by the Superintendent, Assistant Superintendents, and head nurses. Lectures, recitations, and demonstrations will take place from time to time, and examinations at stated periods.

When the full term of two years and six months is ended, the nurses thus trained can choose their own field of labor, whether in hospitals, in private families, or in district nursing among the poor. On leaving the School they will, after passing the final examination, each receive a diploma signed by the Examining Board, and by a Committee of the Board of Managers and the Superintendent of the School, and also a school pin, presented by the Managers as a mark of their esteem and regard. When the School graduated its first class of nurses, it was considered desirable to give them appropriate badges as well as diplomas, and the design of the stork was selected, because of the legend which tells of their unfailing watchfulness, one always remaining awake to warn the others in the event of danger. To this was added the motto "Vigilance," and the whole was also adopted as the seal of the Bellevue Training School.

#### THE REPORT OF THE ALUMNÆ ASSOCIATION.

A NOTHER year of the Alumnæ Association has passed into history—a year of activity and a year of growth; of closer identification with the work of our *Alma Mater* and closer cooperation with those who are carrying its responsibilities.

We have welcomed a new Superintendent of Nurses, whom, as a woman standing high on the records of our profession, we as nurses are delighted to honor. We look with pleasure and pride on the growth and progress of our school, and note with satisfaction the development of greater interest not only in what our School is doing but also in the work of the great Hospital to which it is attached. Our Association also has enlarged the borders of its habitation by the addition of another floor to the Club Rooms. We now occupy three floors of the building, 14 East 42nd Street. Our Club Rooms are open every day to graduates and pupils of the School.

A Registry is maintained where competent nurses can always be secured for all classes of cases and a special effort is made to fill Hospital and District nursing positions.

Regular business meetings are held on the third Thursday of each month, except July and August, and "Afternoon Teas" for social intercourse every Tuesday throughout the year.

The Registry has been very successful during the year; with dues and rents the Club Room has been made self-supporting.

It is now headquarters for the American Journal of Nursing, the Official Organ of our Nurses' societies. The Directors' Meetings of the Nurses' Associated Alumnæ, our National Society, are also held here, and many other committees and societies find our rooms a convenient and central meeting place.

Our Association has pledged this year, the sum of \$500 towards the Endowment Fund of the chair of Hospital Economics at Teachers' College, where the work of fitting graduate nurses for the more responsible positions as teachers of nursing and administrative work has been carried on since 1899 through the efforts and self-sacrifice of a small group of interested members of our profession.

Nine of our members attended the Annual Meeting of the Nurses' Associated Alumnæ, at Richmond, Va., last May. Miss Damer was elected the President of the Association for the third time. Miss Rhodes made chairman of the Eligibility Committee. and Miss Dock chairman of the Committee on Nursing of the Sick in Almshouses. This committee is now investigating the condition and care given the sick in these institutions, and will endeavor in co-operation with the Federations of Women's Clubs, to provide skilled nursing for these helpless people. Miss Damer has been a member of the State Board of Nurse Examiners of New York State since the law regarding State Registration was passed in 1903. She is also President of the Board of Directors of the American Journal of Nursing Company. which publishes the leading Nurses' Journal of the country owned, edited, and controlled by nurses alone. Two of our members, Miss Dock and Miss M. E. Cameron, are on the editorial staff of the magazine, and our association own four shares of stock of the company.

Miss Dock has recently written and published in collaboration with Miss M. A. Nutting a History of Nursing, a most valuable contribution to literature and history, being really the only historical information there is of the work of devoted women among the sick throughout the centuries. A copy of this work has been presented by the author to the Alumnæ Library, which has been increased considerably during the year by the addition of several valuable books.

The Association cordially invites all graduates of earlier classes not yet members and all recent graduates to join its ranks. become sharers in its benefits and pleasures, and help, too, in carrying the responsibilities due as graduate nurses, to the school, to the public, and to the nursing profession.

## BY-LAWS.

#### MEMBERSHIP.

The Society shall consist of Honorary and Active Members. Honorary Members shall be elected by the Board of Managers for valuable aid or important service rendered to the School.

Members shall be those who make an annual subscription.

Active members shall be those who serve on the Board of Managers.

Honorary Members may also be active members.

## BOARD OF MANAGERS.

The Board of Managers shall be appointed by the Mayor according to the contract.

No Member of the Board of Managers shall receive any compensation for services rendered.

Five Members shall constitute a quorum at any meeting. The absence of any member of the Board from meetings of the Board, or of Committees of which he or she may be a member, for a consecutive period of three months, without a sufficient reason given to the Secretary, may be considered by the President as equivalent to a resignation.

Any appointee of the Mayor's to the Board of Managers shall by virtue of such appointment become a member of the Society.

Reports:—The Board of Managers shall make a monthly and annual report to the New York City Visiting Committee of the State Charities Aid Association and shall publish annually a report of the School.

#### OFFICERS.

The Officers of the Society shall be a President, a Vice-President, a Secretary, and a Treasurer. They shall be elected annually by a two-thirds vote by ballot of the Board of Managers from among its Members with the exception of the Treasurer, who need not be a Member of the Board of Managers. In case of the death or resignation of an Officer, a successor for the remainder of the year may be elected by a two-thirds vote by ballot of the Board of Managers at any regular or special meeting of the Board, two weeks' notice in writing having been given by the President or Secretary.

#### NOMINATING COMMITTEE.

There shall be a Nominating Committee for officers consisting of three Members of the Board of Managers, named by the President, who shall prepare and submit a ticket annually to the Board. This ticket must be submitted in writing to each Member two weeks before the Annual Meeting of the Board of Managers.

## PRESIDENT.

The President shall preside at all meetings of the Board of Managers, and shall call Special Meetings at discretion, or upon the written request of three Members of the Board. The President shall appoint all special and sub-committees.

#### VICE-PRESIDENT.

The Vice-President shall in the absence of the President perform the duties of the President.

### SECRETARY.

The Secretary shall perform the duties usually appertaining to this office.

#### TREASURER.

The Treasurer shall present a written Annual Report at the Annual Meeting of the Board of Managers; shall receive and acknowledge all subscriptions and donations; keep the books of the Society; audit the monthly accounts, and make a written report monthly to the Board of Managers.

In the absence of the Treasurer, the President shall appoint some other member of the Board of Managers to audit the monthly accounts.

#### ADVISORY COMMITTEE ON FINANCE.

There shall be an Advisory Committee on Finance composed of two members, who need not be members of the Board of Managers.

The Advisory Committee shall receive, invest, and have charge of the invested funds of the Society.

#### ANNUAL MEETING.

There shall be an Annual Meeting for the election of Officers.

#### BY-LAWS.

The By-Laws of the Sub-Committees must be in accordance with and subordinate to the By-Laws of the Board of Managers. The By-Laws of the Board of Managers must be in accordance with and subordinate to the Article of Incorporation.

## AMENDMENT OF BY-LAWS.

These By-Laws can be amended by a majority of the Board of Managers, at any regular or special meeting, the text of the proposed amendment having been sent to each member of the Board a fortnight previously by the Secretary.

## CONTRACT WITH THE CITY OF NEW YORK

Whereas the Bellevue Training School for Nurses has for many years rendered to the City of New York useful charitable services in training and furnishing female nurses for the sick in Bellevue Hospital, under certain contracts, understandings, and agreements with the City of New York through its officers or agents charged with the duty of managing that Hospital; and

Whereas the premises on 25th and 26th Streets near Bellevue Hospital owned by the said School and long occupied by it as a nurses' home, and for other purposes connected with its said charitable work, have become too small and inadequate to supply the continually increasing needs of Bellevue Hospital and other hospitals in the City of New York for additional female nurses, so that the said School is unable to supply a sufficient number of properly trained and experienced nurses owing to lack of suitable accommodations for housing and instructing such nurses; and

Whereas it has been enacted in Chapter 153 of the Laws of 1906 of the State of New York, in substance, that the Board of Trustees of Bellevue and Allied Hospitals shall have power subject to the approval of the Mayor as to terms and conditions, to enter into a contract, or contracts, with the Bellevue Training School for Nurses for the occupation and use of any building or buildings as a training school for nurses, for the purpose of continuing, improving, and increasing its service in supplying to Bellevue and other hospitals trained nurses for the sick in said hospitals; and

Whereas the City of New York has recently acquired a tract of land on 25th and 26th Streets, abutting on East River, and near the premises referred to above owned by the Bellevue Training School for Nurses, on which lands it is proposed to erect a building or buildings for use in connection with and as a part of Bellevue Hospital, which building or buildings it is proposed shall be used by the Bellevue Training School for Nurses for the purpose of continuing, improving, and increasing its said services and for the purpose of carrying on its work on a larger scale and in a more effective manner, under the supervision of the Board of Trustees of Bellevue and Allied Hospitals, pursuant to this contract and to all the statutes applicable thereto, or applicable to the parties thereto;

Now, therefore, this contract between the City of New York, by the Board of Trustees of Bellevue and Allied Hospitals, hereinafter called the Board, of the first part, and the Bellevue Training School for Nurses, hereinafter called the School, of the second part, and approved as to terms and conditions by the Mayor.

Witnesseth, that the City of New York has granted, demised, and let, and doth by these presents grant, demise, and let unto the School, the building or buildings and appurtenances that shall hereunto belong, about to be constructed, or being constructed on the tract of land belonging to the City of New York on 25th and 26th Streets between the East River and the premises belonging to the School, for the use, and occupation when constructed and completed, by the School as a training school for nurses for the purpose of continuing, improving, and increasing the service of the School in supplying to Bellevue and other hospitals trained nurses for the sick in said hospitals.

To have and to hold the same so long as the School shall continue to carry out the objects and purposes defined in its charter, or such other objects and purposes as by any future amendment of said charter may be authorized, and shall faithfully keep, perform, and observe the covenants and conditions herein contained on its part to be kept, performed, and observed, or until this agreement shall be cancelled or amended as hereinafter provided, or until the said building shall be surrendered by the School as hereafter provided.

This contract, however, shall not go into effect or be of any force or validity until the said building or buildings shall have been completed and the School notified thereof in writing by a duly authorized representative of the City.

It is further stipulated, promised, and agreed by the parties hereto, as follows:

The Board shall have general oversight and supervision of

the said building or buildings and of the work carried on therein by the School. The Board and its duly authorized agents or representatives shall at all times have free access to every part of said building or buildings for the purposes of general visitation and supervision, and of the performance of any duties devolved upon it by the laws of the State of New York or the ordinances or regulations of the City of New York or of any of its boards, departments, or officers.

The Board shall, during the continuance of this contract, and subject to such modifications thereof as may be mutually agreed upon, and subject to sufficient appropriations by the Board of Estimate and Apportionment, pay to the School the salaries for the superintendence of the nurses and the compensation of each nurse actually provided and approved by the Board, together with maintenance. That amount of said salaries and compensation shall be determined in advance by mutual agreement between the Board and the School.

The School shall take possession of, accept, use, and occupy the said building or buildings and appurtenances when completed as a training school for nurses for the purpose of continuing, improving, and increasing its service in supplying to Bellevue and other hospitals trained nurses for the sick in said hospitals.

It shall manage the nursing department of Bellevue Hospital under the supervision of the Board and in accordance with such general rules and regulations as the Board shall promulgate It shall provide for the supervision of the nursing service of the hospital and shall provide female nurses as required by the Board, not, however, in excess of such number as can reasonably be accommodated in the said building or buildings.

The School shall continue, substantially as heretofore, to devote its income to the purposes of the School, but it shall not be bound to use any part thereof for the payment of salaries; but may use all or any part thereof for the miscellaneous uses of the School, in accordance with its charter.

The School shall render to the Board annual reports of its operations, with statements of receipts and expenses, and shall submit to examination its books and accounts whenever required by the Board or by the Comptroller of the City of New York.

The School shall amend its by-laws so as to provide for its management by the Board of Managers to hold office and be appointed as herein set forth, which amendments, when made, shall remain in force and shall not be altered, modified, or repealed during the continuance of this contract except with the consent of the Board.

The said Board of Managers shall be known as "Board of Managers of Bellevue Training School for Nurses." It shall consist of thirty-three members. At all times the President of the Board of Trustees of Bellevue and Allied Hospitals, the Commissioner of Public Charities, and the Commissioner of Health shall be three of said members by virtue of their respective offices.

Within ninety days after the execution of the contract the Mayor shall appoint five members of the Board of Managers to serve for a term of one year, five members to serve for a term of two years, five members to serve for a term of three years, five members to serve for a term of four years, five members to serve for a term of five years, and five members to serve for a term of six years, from February 1, 1907. Thereafter in each year, in the month of January on or before the twentieth day thereof, prior to the expiration of the term of any class of managers, the Mayor shall appoint five members for the full term of six years. Of the members whose terms shall date from the first day of February, 1907, not less than twenty shall be appointed from the present Board of Managers of the School.

Notice in writing of the dates on which appointments, excepting the first, to said Board of Managers, are to be made shall be given by the Mayor to each of the members except those whose terms are about to expire, at least ten days prior thereto, and, for the purpose of making the appointments aforesaid, except the first, the members of said Board of Managers, except those whose terms are about to expire, shall present to the Mayor a list of not less than fifteen persons to be appointed members of said Board of Managers to fill a vacancy or otherwise. Appointment to said Board of Managers shall be made from such list or lists. The Mayor shall fill any vacancy in the said Board of Managers caused by the death, resignation, or otherwise, of a Manager, by the appointment of a Manager to hold office for the unexpired term. Such appointments shall be made from a list of not less than three persons, furnished on notice from the Mayor by the Board of Managers.

Either party to this contract may withdraw therefrom, and may cause this contract to be cancelled by giving to the other party twelve months' notice in writing of its determination to that effect, and at the expiration of twelve months from the receipt of such notice, this contract shall cease and determine, and thereupon the School shall and will quietly and peaceably yield up and surrender unto the Board, or its successor or successors, all and singular the premises herein referred to, and remove all its property therefrom.

This contract shall be wholly cancelled and annulled, or from time to time altered or modified, as may be agreed in writing between the parties or their successors, anything herein contained to the contrary in anywise notwithstanding.

IN WITNESS WHEREOF, the parties hereto have executed in duplicate the foregoing contract this twenty-first day of June, 1906.


